## WELCOME to Issue 5 of Midlands Matters, our Partnership newsletter.

As I write, we remain in a challenging phase of the Covid-19 pandemic. This week sees an important step in the gradual reopening of our economy, with shops across the region opening their doors again, as well as the welcome return of some secondary school pupils.

However, whilst I welcome this news and the encouraging signs that the first wave of the pandemic is slowing across the Midlands, we must be vigilant – the R rate is reported as close to 1 and I am in continued admiration of those who, right across our partnership continue to do everything in their power to avoid a second wave.

Your unrelenting work, safeguarding life, is of the utmost value to everyone in every part of our region - and beyond.

I have been profoundly impacted by the recent demonstrations in the Midlands. Black Lives Matter - and I understand all those who have chosen to protest peacefully and who have insisted on social distancing. As leaders and influencers in the diverse communities that make up the Midlands, we have a responsibility to understand, to listen and to support. I hope that the positive momentum around this issue will drive progress towards levelling up our society – not just in economic terms, but in terms of social and racial inequalities too.

I am extremely conscious of the accelerating, adverse consequences of the pandemic on the Midlands and UK economies. Our <u>Observatory's</u> <u>Covid-19 Monitor reports</u> show the stark reality unfolding, including sharp declines in business activity and a rapid rise in unemployment. Our discussions with firms, organisations and institutions throughout the region have provided and will continue to provide a powerful route through which to gather insights that can help inform preparations for recovery – and ensure the pressures on our region are understood by Government.

Our Observatory has published the <u>latest Quarterly</u> <u>Economic Commentary</u>, which despite the economic impact of Covid-19 gives me cause for modest optimism that the Midlands, with our vast assets, innovative business community and diverse regional capabilities, will prevail and grow strongly in time, once again. The opportunities to grow the Midlands economy are superbly demonstrated by the Access to Toton project – linking HS2 in the East Midlands to vastly improved regional connectivity – read more on this below.

Recently, the Secretary of State for International Trade, the Rt Hon Liz Truss MP, asked me to convene a meeting of Midlands SMEs to discuss forthcoming Free Trade Agreements, which was attended by participants from nearly 70 outstanding Midlands SMEs. International trade contributes over £90bn per year to the Midlands economy - in the context of recovery, it is clear that successfully stimulating amplified international trade and exports will be a critical cornerstone on which we will rebuild.

Another underreported aspect of the pandemic is the impact on mental health. We are collectively enduring a radical departure from usual ways of life and ways of working. Financial pressures in many homes are often severe. Constraints for families are extreme and children have in some respects have made the greatest adjustments and the most sacrifices. <u>Midlands Engine's work in</u> <u>partnership on mental health</u>, which aims to support employers to improve workplace mental health and wellbeing, has already adapted to provide additional resources for home workers.

Playing our part, in every way we can – adding value and bringing additionality, remains our focus. I continue to be inspired by the most exceptional and extraordinary work being delivered by all Midlands Engine partners – and it is clear to me that our partnership principles have been galvanised further still in recent months, committed as we are to work together for our businesses, and for all who live in the Midlands.
